Malvern Canine Hydrotherapy – Terms and Conditions

We want you and your pets visit to Malvern Canine Hydrotherapy Centre to be an enjoyable one. To ensure our centre runs safely we ask that you please read carefully through our terms and conditions. By bringing your dog for sessions at our centre you are agreeing to adhere by them. If you have any questions about any of the listed points please contact us and we'll be happy to go through them with you.

- Whilst every care is taken to ensure the safety of the dogs undergoing treatment all dogs
 receive hydrotherapy treatment entirely at their owners' risk and we reserve the right to refuse
 treatment to any dog that we feel would not benefit from hydrotherapy treatment.
- Dogs will not be treated without the prior authorisation of their veterinary surgeon.
- Dogs with infectious or contagious conditions, such as ear, eye or skin infections, gastric upset, kennel cough and so on will not be treated. Owners are advised to cancel all appointments with at least 24 hours' notice, until the condition is clear. Normal cancellation conditions will apply.
- It is advised that owners do not feed their dogs within three hours of visiting the centre and that dogs are toileted prior to their visit.
- For their safety, when not undergoing treatment all dogs must be kept under control and must be on a lead at all times both in the therapy room and around the business centre.
- Owners are required to notify us if their dogs condition appears worse/ deteriorates, or if their vet advises to suspend or stop their treatment.
- When visiting the centre you are advised to wear sensible shoes and clothing. The pool room
 can become very wet during your dog's swimming session and the floor may become very
 slippery.
- Malvern Canine Hydrotherapy cannot be held responsible for any loss or injury to any person, animal, possession (including vehicle) howsoever occasioned, whilst at the business centre. Our 24hr emergency vet is Vets Now, Worcester (01905 312303)
- Individual sessions must be paid for in full on the day of treatment ..
- We reserve the right to cancel any session; i.e. power failure, maintenance or illness. We will
 notify you by your preferred contact method in the event of cancellation giving as much notice
 as possible.
- We reserve the right to use video footage and photographic stills taken during sessions. If you
 would prefer not to have videos/photographs used for any reason please speak to us prior to
 signing.
- It is the owner's responsibility to clean up after their dogs, whilst on company premises and its surrounding environment.
- In the interests of health and safety any children visiting the centre must remain with the accompanying adult at all on the premises.
